READ CAREFULLY BEFORE SIGNING - THIS IS A RELEASE OF YOUR RIGHTS TO PURSUE ALL CIVIL ACTIONS AGAINST BOURBONTOWN TOURS LLC, AND ITS EMPLOYEES, AGENTS, AND ASSIGNS (HEREAFTER "RELEASED PARTIES") FOR DAMAGES, PERSONAL INJURIES OR WRONGFUL DEATH THAT MAY OCCUR DURING TOURING ACTIVITIES AS A RESULT OF INHERENT RISKS ASSOCIATED WITH TRAVEL AND ALCOHOLIC BEVERAGE CONSUMPTION OR AS A RESULT OF YOUR NEGLIGENCE OR THE NEGLIGENCE OF THIRD PARTIES.

1. I am aware of the inherent risk and dangers involved with interstate and intrastate travel, as well as, the consumption of alcoholic beverages. 2. I acknowledge that in enrolling and participating in a Bourbontown Tours, LLC tour, I may be a passenger in a vehicle owned and/or operated by a third party carrier, and I accept and assume all the dangers that are inherent in this activity, whether or not these dangers are obvious. I further acknowledge that I will abide by all rules, conditions and restrictions of Bourbontown Tours, LLC. 3. I hereby certify that I am in good health and that I am physically and mentally capable of traveling and participating in a Bourbontown Tours, LLC tour. 4. I understand and agree that any bodily injury, death or other loss that occur as a result of my participation on a Bourbontown Tours, LLC tour, a passenger on a third party carrier, and/or consumption of alcoholic beverages are my responsibility. 5. I hereby waive and forever release Bourbontown Tours LLC, and its agents and employees of all claims of liability or responsibility that may arise from injury or damage that may occur as a result of my participation on a Bourbontown Tours LLC tour, a passenger on a third party carrier, and/or consumption of alcoholic beverages, whether caused by my own negligence or the negligence of a third party. 6. I further agree to be bound by the terms and conditions of any enrollment agreements required as a condition to participation in a Bourbontown Tours LLC tour.

I agree to obey all rules, regulations, and requests of Bourbontown Tours LLC, third party carriers, and tour destinations. 3. I will not hesitate to seek assistance from a staff member.

BOURBONTOWN TOURS LLC, AND ITS EMPLOYEES, AGENTS, AND ASSIGNS, AND ALL RELATED ENTITIES FROM ALL LIABILITY WHATSOEVER FOR PERSONAL INJURY, PROPERTY DAMAGE, WRONGFUL DEATH, HOWEVER CAUSED, INCLUDING, BUT NOT LIMITED TO, MY NEGLIGENCE OR THE NEGLIGENCE OF THIRD PARTIES. I HAVE FULLY INFORMED MYSELF OF THE CONTENTS OF THIS LIABILITY RELEASE & ASSUMPTION OF RISK BY READING IT BEFORE I SIGNED IT ON BEHALF OF MYSELF AND MY HEIRS.
